General Instructions:

This is an Initial Notification/ Compliance form for Paint Stripping and Miscellaneous Surface Coating Operations facilities subject to Subpart HHHHHH, 40 CFR Part 63.11169 – 63.11180. **Paint Stripping Operations** are those that perform paint stripping using methylene chloride (MeCl) for the removal of dried coating (including, but not limited to, paint, enamel, varnish, shellac, and lacquer) from wood, metal, and plastic. **Motor Vehicle/Mobile Equipment** involves the spray application of coatings at area sources to automobiles, light trucks, heavy duty trucks, buses, construction equipment, self-propelled vehicles and equipment that may be drawn and/or driven on a road. **Miscellaneous Surface Coating Operations** involve the spray application of coatings that contain compounds of chromium (Cr), lead (Pb), manganese (Mn), nickel (Ni), or cadmium (Cd) to miscellaneous parts and or products made of metal or plastic, or combination of both".
